Profile of Richmond, Virginia

Richmond, known as "RVA," is a city of nearly a quartermillion people in a growing and diverse region of 1.2 million people. It is the capital of Virginia and is located less than 100 miles from the nation's capital and within 750 miles of two-thirds the U.S. population.

Ideally situated at the intersections of Interstates 95, 64 and 295, and boasting an international seaport and airport, two major rail freight lines and Amtrak service, Richmond's thriving economic base includes research and development, manufacturing and distribution, commerce, government, law, banking and tourism.

The James River makes Richmond the only urban U.S. city with Class IV white water rapids running through its downtown. The 550 acre James River Park system is recognized as one of the Southeast's best urban parks. Richmond is among US News & World Report's top 25 places to live and Southern Living cited Richmond as "one of the South's best cities." Time Magazine noted Richmond is #2 on the list of "25 cities Where Millennials are Moving."

Our Government

Richmond's vision and mission is to provide professional, compassionate and accountable government services to *every* citizen. In RVA, the mayor serves as the city's chief executive officer, and daily operations are directed by the chief administrative officer appointed by the mayor. The city's nine-member elected city council establishes local laws, approves the mayor's city budget and provides government policy and oversight.



Richmond will continue to address strategic needs and priorities through our fiveyear \$719.6 million Capital Improvement Plan, including:

* \$15.1 million for education, * \$14.4 million for culture and recreation projects, including park and library enhancements ; * \$20.3 million for public safety, including a new emergency radio communications system and building upgrades; * \$245.7 million for wastewater and stormwater utility upgrades; * \$284.3 million for gas and water utility improvements; \$108.2 million for transportation, including the downtown corridor Bus Rapid Transit project; * \$12.5 million for economic and neighborhood development projects, including an aggressive transformation of existing public housing.

Our Future Challenges

With a highly educated, talented and growing workforce, along with continued expansion in the government, medical, education, law, transportation and manufacturing industries, Richmond is well positioned to meet the challenges before us.

Richmond's poverty rate is approximately 25.5%. We will further initial improvements made in FY2017 with a clear focus and commitment to continued investments. We are nearly doubling our Community Wealth Building budget to \$2.1 million in FY2018. A majority of our public schools lack full state accreditation, and to address this pressing priority, our mayor, city council, school board and

administration approved an Education Compact, clearly defining actions we will utilize to improve academic progress.
