### ADDITIONAL NEW BUSINESS INFORMATION

- After your license has been established, a Business Tangible Personal Property Tax Account will be added, if applicable.
- Business Licenses are mailed on the 15<sup>th</sup> of each month by our third party vendor.
   Please allow an additional 7-10 business days from that date for you to receive the actual Business License. No business licenses will be printed or mailed after November 15<sup>th</sup>.
- Business License and Business Tangible Personal Property renewals must be filed on or before March 1<sup>st</sup> of each year. The forms will be mailed to you. If you have not received the forms, please visit our website <u>www.rva.gov</u> to download the blank forms.
- Business License Renewal payments must be received or postmarked on or before March 1<sup>st</sup> in order for the Business License to be processed.
