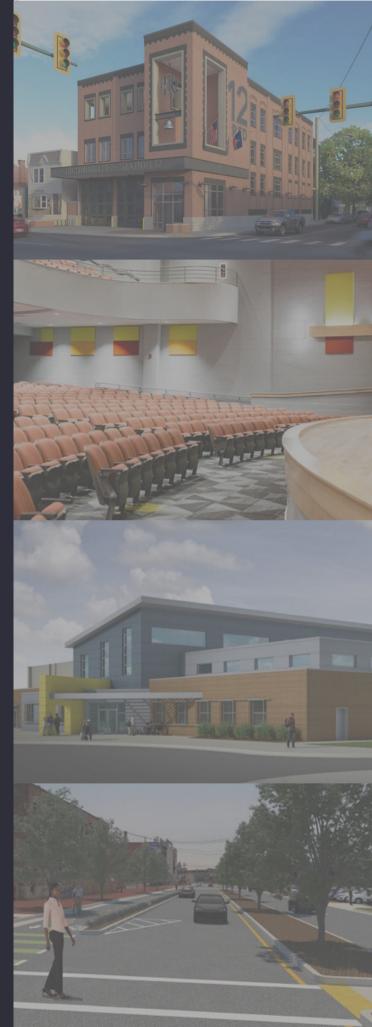

# **Richmond Yesterday**

Richmond's history begins in 1607 when Captain Christopher Newport led English explorers to land inhabited by the Powhatan Nation on the banks of what is now known as the James River. Settlers flocked to the region during the construction of Fort Charles. Soon, the community grew into a bustling trading post for furs, hides, and tobacco.

Named after a London suburb, Richmond was officially

founded in 1737 by Colonel William Byrd II. Known as the father of Richmond, Byrd worked with William Mayo, developed maps of the area, and sold plots of inherited lands on the north and south sides of the James River. Richmond was incorporated as a city and officially named Virginia's capital in 1782.



# **Richmond Today**

Today Richmond is home to an estimated 226,623 citizens (source: Weldon Cooper Center for Public Service) and offers a diversified employment base that extends from chemical, plastics, and beverage manufacturing to banking, biotechnology, knowledge-based services, and high-tech fibers. Consistently ranked among "Best Places to Live and Work in America" by several national publications, Richmond offers easy access to the beach, mountains, and Washington, D.C.

The city features a broad array of local attractions, including

historic landmarks, museums, and sports and entertainment venues; its own symphony, professional ballet, and opera; and a nationally recognized restaurant scene. Richmond also boasts one of the nation's largest river park systems, attracting visitors with rapids, fishing, mountain biking trails, and a thriving population of American bald eagles.

## **Richmond Tomorrow**

The City of Richmond continues to grow, thrive, and look toward the future. Two initiatives in particular show how the best of Richmond's history is yet to be written.



## **One Richmond**

Mayor Levar M. Stoney's One Richmond plan will work to improve the lives of all city residents by addressing public safety and child poverty, and by developing an education compact with city administrators, city council, and the city's school system. The plan seeks to improve city services and make City Hall more efficient and transparent. The ultimate goal is a city "that works, and works together."



# **Richmond 300**

Intended as a guide for growth in the city through its tricentennial in 2037, Richmond 300 seeks to right injustices of the past while fostering a more welcoming, inclusive, and innovative city of thriving neighborhoods. The plan will promote a more diverse economy, create and maintain high-quality neighborhoods, develop an equitable transportation network, provide inclusive housing, reconnect the city's neighborhoods, and support a prosperous ecosystem.

**RVAMayor@RVA.gov** 804.646.7970 (office) 804.646.7987 (fax) Levar M. Stoney is serving his second term as the 80th mayor of the City of Richmond and is the youngest person to hold the office. He serves as President of the Democratic Mayors Association and is an Advisory Board member of the U.S. Conference of Mayors, where he chairs the Children, Health and Human Services Committee.

Mayor Stoney believes government can play a powerful role as a creator of opportunity for all residents and has made investing in children and families his top priority. During his term, he has made the largest individual budget investment in public education of any mayor in a generation. His administration has increased funding for classrooms and the maintenance of school facilities, constructed three new schools in Black and Brown neighborhoods, and built a partnership with local providers and the philanthropic community to create access to quality afterschool programming for every Richmond Public Schools (RPS) child enrolled in elementary and middle school.

A strong advocate for economic growth, Mayor Stoney launched programs that strengthen neighborhoods and ensure all residents share in the city's progress. Using the award-winning Richmond 300 plan as a guide, the mayor's administration has prioritized the creation and preservation of quality affordable housing, public works infrastructure, transportation, and jobs.

As Richmond emerges from the COVID-19 pandemic, the mayor has pledged to invest a record \$10 million per year in the Affordable Housing Trust Fund in perpetuity – a 1,200% increase from the start of his mayoralty. Mayor Stoney also founded the first of its kind Eviction Diversion Program, designed to address Richmond's troubling eviction rates.

Mayor Stoney has made upgrading city infrastructure a major priority. His administration's historic investments have resulted in newly paved roads in often neglected neighborhoods and the dedication of \$78 million in American Rescue Plan Act funds toward the rehabilitation and construction of four community centers, providing access to recreation and city services within walking distance of 100,000 city residents.

Under his leadership, the Central Virginia Transportation Authority (CVTA) approved a \$113 million regional investment that will enable the completion of the Fall Line Trail. The GRTC Pulse, a bus rapid transit system, launched and exceeded all ridership expectations. Thanks to further investments and administration support, mass transit in the city is now free for all riders.

Formulation of Richmond's annual fiscal budget begins with the mayor in collaboration with members of the Department of Budget and Strategic Planning team and city leadership. The mayor's proposed budget is presented to Richmond City Council, the body in charge of establishing each year's official city budget. Richmond City Council then studies the content, develops applicable amendments, and adopts a balanced budget by the annual deadline of May 31.

Richmond is divided into nine voter districts. Thusly, nine people are elected from individual Richmond Voting Districts to represent residents as members of Richmond City Council. These nine City Council members are responsible for creating and amending local laws, providing policy and government oversight, appointing members to boards and commissions, and approving the annual Richmond Government Budget.

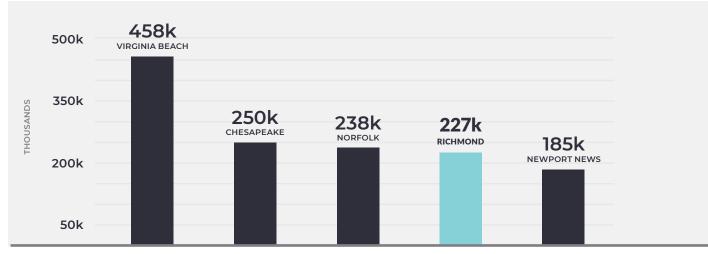
#### Population

As reflected in Table 1, Richmond's population has increased since 2000, adding an estimated 28,833 residents over the past two decades. Richmond is the fourth most populous city in Virginia, as shown in Graph 1.

#### Age

The age distribution of the City's population as of 2019 is presented in Table 2. The three age groups with the largest total population counts include those between ages 25 and 29 (27,351), 30 and 34 (23,619), and 20 and 24 (19,203).

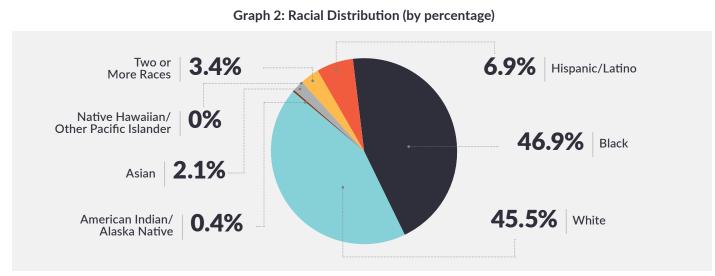

#### Race

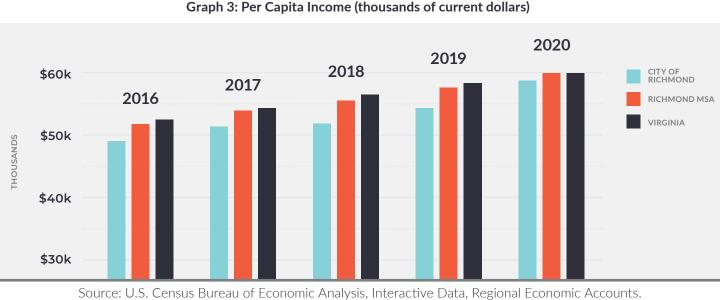
The racial distribution of the City's population as of 2019 is presented in Graph 2. The City is nearly equal in its black and white population, with roughly 47% of residents identifying as Black, and roughly 46% identifying as White.

#### Income

An annual comparison of per capita personal income from 2016 to 2020 is presented in Graph 3. In 2020, per capita personal income for the City of Richmond was \$59,148, which is slightly lower than that of both the metropolitan area (\$61,148) and the state (\$61,958).

#### Unemployment

The annual average unemployment rates from 2014 to 2020 are illustrated in Graph 4 below. In 2020, the annual average unemployment rate for the City of Richmond was 8.8%, which was considerably higher than both the regional average of 6.7% and the state average of 6.2%, and slightly higher than the nationwide average of 8.1%. This significant increase in the unemployment rate can likely be attributed to economic challenges associated with the ongoing COVID-19 pandemic.

#### SUBJECT: FY2023 - FY2027 CAPITAL IMPROVEMENT PLAN

Dear Members of the Planning Commission and Members of City Council:

I am pleased to present to you the Proposed Capital Improvement Plan (CIP) for Fiscal Years 2023 - 2027. The Proposed CIP for FY2023 – FY2027 is a sound, fiscally responsible spending plan that leverages local, state, and federal funding to build and maintain the Richmond we deserve – one that is sustainable, equitable, and innovative – ensuring a high-quality of life for all citizens.

As I stated in the 2022 State of the City Address a few weeks ago, Richmond is moving forward and making bold moves. Over the past year, the City has completed over 20 capital projects, including renovations to Abner Clay Park and the Ann Hardy Family Life Center, new bike lanes along 1<sup>st</sup> and 2<sup>nd</sup> Street, and streetscaping improvements along major thoroughfares such as Brookland Park Boulevard and Forest Hill Avenue.

These investments in multi-modal transit, community resources, and green space are examples of the bold investments that are continued throughout the FY 2023 – FY 2027 CIP - all towards the goal of building One Richmond – a city that works, and works for all.

The Proposed FY 2023 CIP is \$98.5 million, of which \$57.4 million is dedicated to transportation and schools. In the five year CIP that you will be reviewing, \$449.8 million, or 71.7 percent, is dedicated to schools and transportation, \$212.5 million is for schools and \$237.3 million is for transportation and infrastructure improvements.

The FY 2023 CIP funding is comprised of \$38.3 million in general fund supported debt, \$10.0 million in short-term debt funding, \$10.0 million in cash funding, and \$40.2 million in federal, state, and regional-supported dollars.

The philosophy of this CIP is "Maintain and Investing in our Assets" as we build "One Richmond". To that end, we focused on several key priorities in this recommendation. They were to:

- Review and identify projects close to completion and fund those where possible;
- Fund projects that are related to health and safety concerns;
- Fund projects that address citizen concerns and issues;
- Fund projects that leverage local funding to increase State and Federal revenues; and
- Fund projects that stimulate and or promote economic opportunities.

To move forward, projects included address these key priorities as well as other projects to make our City more inclusive, equitable, and competitive. To name a few, I am proposing funding to: increase the allocation towards improving city streets, increase funding for public safety fleet, provide \$200 million for two new school facilities, and provide nearly \$28 million in funding for the Enslaved African Heritage Campus.

Also, for FY 2023, this budget proposes funding in the following categories:

#### **Capital Planning Program**

Funding in this category totals \$10.0 million in FY 2023. This category consists of a project/program focused on better aligning the City's Capital Improvement Plan planning process with "best practices" of highly rated local governments.

#### **Capital Investment Opportunities**

The CIP includes \$150,000 for Percent for the Arts, utilizing a percent for the arts fund balance allocation. The Enslaved African Heritage Campus is provided nearly \$28 million in funding over the five years of the CIP. This project is a major priority and this funding provides the foundational funding needed to reenergize this project and push for the completion of a National Slavery Museum. The five-year proposed funding for the Capital Investment Opportunities section of the CIP is \$29.0 million.

#### Capital Maintenance Program

This category has been created to develop a consolidated funding program for the maintenance of city facilities. This category combines the projects included in project categories presented in previous year CIPs such as City Facilities, Public Safety, and Culture/Recreation. Funding for the Capital Maintenance program in FY 2023 totals \$15.6 million, and includes projects such as maintenance for major buildings and parks, and abatement of the Richmond Coliseum.

#### **Capital Transportation Program**

Beginning in FY 2023, the Transportation program is divided into two categories: Federal/State/Regional funding, and General Obligation (G.O.) Bond funding, in order to create distinction between projects funded by non-city funds versus projects the City funds.

Funding for the Federal/State/Regional category totals \$35.2 million and includes projects such as rehabilitation of the Mayo Bridge, construction of portions of the Fall Line Trail, and streetscaping improvements along the GRTC Bus Rapid Transit (BRT) Pulse line on Broad Street downtown, and along Hull Street on the City's southside. Funding in the G.O. Bond category totals \$22.1 million, of which \$17.0 million is allocated to Complete Streets, a comprehensive transportation improvement project established in last year's CIP to enable the City to strategically invest funding in street completion; funding sidewalks, curb & gutters, pedestrian crossing, and paving.

#### **City Equipment and Other Investments**

This category includes over \$10.0 million for vehicle replacement, of which \$3.9 million is for fire apparatus and \$3.0 million is for Police vehicle replacement.

#### **Richmond Public Schools**

School Capital Maintenance is proposed at \$2.5 million in FY 2023. In addition, \$200 million is planned in FY 2024 for the school modernization plan. The five year proposed funding is \$212.5 million.

# **COMPLETED PROJECTS**

### COMPLETED PROJECTS OVERVIEW

As the city continues the work towards the vision of "One Richmond - a city that works, and works for all" - maintaining and expanding the "built environment" is just as critical an investment as those that are made in education, public safety, and mental health, among other focus areas.

You may recall that, in line with the aforementioned vision, the theme of last year's Capital Improvement Plan was "maintaining and investing in our assets". Moreover, one of the top priorities was to "review and identify projects close to completion and fund those where possible".

Over the past year, the city has completed over 20 capital projects - including community centers, transportation improvements, and facility improvements. This provides not only the opportunity for ribbon-cutting ceremonies, but the opportunity to improve the quality of life for both current future residents of the City of Richmond.



This section provides an overview of the capital projects that have been completed between the  $3^{rd}$  quarter of Fiscal Year 2021 and the  $2^{nd}$  quarter of Fiscal Year 2022, and as a result, have been removed from the active projects listing over the past year.

#### HIGHLIGHTED COMPLETED PROJECTS

1<sup>st</sup> and 2<sup>nd</sup> Street Buffered Bike Lanes - This project designed a protected cycle track in the City's central business district along seven blocks of 1<sup>st</sup> Street and six blocks of 3<sup>rd</sup> Street, from Spring Street at the Virginia War Memorial via Byrd Street to 3<sup>rd</sup> Street to Franklin Street to 1<sup>st</sup> Street to the I-95 overpass at Duval Street. The project will connect to the existing bike lanes on South 2nd Street and the Robert E. Lee Bridge.



**Abner Clay Park** - This project began in 2011, and the scope included major renovations to the entire site, including minor utility upgrades (stormwater structures and electrical work for pedestrian-scaled lighting), sidewalk and plaza improvements, athletic field improvements, a new basketball court, a new pavilion structure, and landscaping.



Ann Hardy Family Life Center - In 2011, the department commissioned a campus study of the entire property at the City's Ann Hardy Plaza Community Center located at 3300 First Avenue. The study addressed the development of a plan for the entire park and recreation amenities. Included in this plan are minor renovations to the existing center, as well as renovations and various improvements to the property. The Campus Plan included an expanded parking area, additional lighting, new basketball court, splash pad, walking trail, new landscaping and beginning renovations to the community center building. The plan also included additional site improvements and building upgrades. Work is currently underway on interior second floor renovations. Funding was requested in FY 2020 for roof replacement and new windows. This funding completes the planned renovations to this facility.

## **COMPLETED PROJECTS**



**Brookland Park Boulevard Streetscape** - This project completed streetscape improvements along Brookland Park Boulevard. The project area included seven blocks, from Montrose Avenue to Barton Avenue. The project included street lighting, landscaping, traffic calming, pedestrian facilities and drainage improvements.



**Forest Hill Avenue: Hathaway Road to East Junction Powhite Parkway** - The project installed a five lane section with curb & gutter, sidewalks, bike lanes, closed storm sewer system, street lighting and landscaping from Powhite Parkway to Hathaway Road.

\*Citywide (CW) refers to capital projects with a project area encompassing more than one Council District, or projects that address a citywide issue, such as traffic control signal replacement.

### BACKGROUND

The City continues to emphasize the importance of addressing its infrastructure needs while also investing in neighborhood projects and improvements. The Capital Improvement Program (CIP) is used to invest in and develop capital projects strategically. A project that is included in the capital budget is broadly defined as requiring the expenditure of public funds for the purchase, construction, enhancement, or replacement of physical infrastructure/assets.

To be included in the CIP, a project should cost more than \$25,000 and must have an expected useful life greater than the life-span of any debt used to fund the project. Projects include improvements to roadways, sidewalks, and bikeways; improvements to neighborhood parks, libraries, and recreational facilities; construction and major renovations of schools and other city facilities; economic development activities; acquisition of property; and the efficient operation of the water, sewage and gas systems. Other costs associated with the capital budget include, but are not limited to, architectural and engineering fees and site development.

In line with the practices of a well-managed government and charter requirements, the City uses a long-range planning process to develop a five-year CIP. Each capital project included in the five-year program has been recommended for additional or new funding in the first fiscal year of the plan and/or included as a planned project in the subsequent four fiscal years. Because of the multi-year nature of the CIP, it is a "living" document that outlines the project's past and future. For example, as a project is developed, the amount and timing of expenditures may allow budget appropriations to be moved out in the CIP or require that the appropriations be accelerated and the budget amount increased or decreased. Therefore, a detailed analysis is conducted each year to ensure that the appropriate levels of spending and types of spending by project are understood and captured in the CIP.



### **GUIDING PRINCIPLES**

For the CIP included in this budget, the City employed the fundamentals of outcome-based budgeting in evaluating and recommending projects and funding. These basic principles include:

- Begin the process with departments closing and/or updating prior year capital projects and identifying new capital or funding needs;
- Identify and develop capital needs based on citizen, legislative, and administrative priorities and regional issues;
- Recommend a CIP that completes existing projects and appropriately funds new projects or costs within available funding levels;
- Continue fiscal processes to require that pay-as-you-go revenues or other bond facilities are budgeted in a manner that maximizes their use first;
- Ensure management of assets in keeping with best practices while preserving the existing tax base; and
- Position the City for the future through good financial stewardship and by outlining a realistic CIP plan within existing resources.

To guide the CIP decision-making process, projects, both new and existing, were evaluated on the degree to which they meet the following objectives or criteria:

- Address health concerns, safety or emergency needs;
- Ensure basic infrastructure is maintained and improved so that the useful life is maximized;
- Meet a legal or contractual obligation or federal or state mandate;
- Leverage outside funding including federal, state, regional or private funding;
- Result in unacceptable outcomes if the project is deferred;
- Enjoy broad community support; and
- Support the priority initiatives included in one or more of the City's seven focus areas.

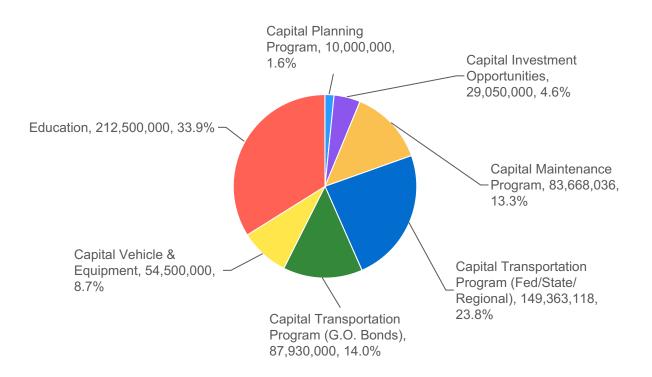

### SUMMARY OF CIP FUNDING AND MAJOR CIP PROJECTS

The Adopted General Fund CIP totals \$627.0 million for FY 2023 - 2027. Of that amount, \$98.5 million is included in Fiscal Year 2023.

FY 2023 - 2027 Adopted Capital Improvement Plan: Funding by Category



The City's top priorities of schools and roads are recommended to receive 71.7 percent of the adopted funding. Funding for school modernization, maintenance, and new construction is funded at \$212.5 million. Transportation infrastructure is funded at \$237.2 million. This includes funding for complete streets at \$59.4 million; major bridge improvements at \$6.5 million; improvements to major thoroughfares such as Hull Street funding at \$18.6 million. Funding to build the Enslaved African Heritage Campus, and to address public art totals \$29.0 million. Maintenance of city facilities totals \$83.6 million, and maintenance and replacement of the City's fleet totals \$54.5 million. The Capital Planning Program provides funding for planning and design of new city facilities and totals \$10 million.

### **DEBT MANAGEMENT POLICIES**

A key component of the CIP is the availability of debt capacity to finance CIP projects. A review of the City's debt management policies resulted in a request to City Council to revise the policy. These policies and guidelines establish parameters for the planning, issuance, and management of debt. The following summarizes the revisions to the policies recently adopted:

- The amount of tax supported debt service will not exceed ten percent (10%) of the total budgeted expenditures for the General Fund and Richmond Public Schools plus the non-local portion of the recurring special funds for Street Maintenance.
- The City will not incur tax supported general obligation debt in excess of three and three-quarter percent (3.75%) of its total taxable assessed values;
- Tax supported general obligation debt will be structured in a manner such that not less than 60% of the outstanding debt will be retired in 10 years;
- The City will issue debt with an average life that is consistent with the useful life of the project with a maximum maturity of 30 years; and,
- The City will strive to provide cash funding for a portion of the five-year CIP.

As part of the debt management policy update, several changes have been incorporated into the CIP's debt management strategy. These strategies are in keeping with other well-managed governments within the Commonwealth, particularly those rated Triple-A by the three rating agencies. The Adopted debt utilized in funding the FY 2023 - FY 2027 Capital Improvement Program is within each of the limitations described above.

### FUNDING THE CAPITAL IMPROVEMENT PROGRAM

Funding Source	Description
Bonds (Debt)	The City's debt is defined by the sources of repayment, general fund supported debt service and non- general fund supported debt. General fund supported debt is pledged to be repaid from tax revenue and is referred to as general obligation or G.O. bonds. Other self-supported debt, which is typically issued for utilities and communications projects, is intended to be repaid from revenue derived from other sources, such as fees or user charges.
Special Revenue Funds	These are direct cash contributions to specific CIP projects directly related to the special fund.
Bon Secours Cash Funding	This is a cash contribution from Bon Secours Health System resulting from an agreement between Bon Secours and the City, relating to the Washington Football Team Training Camp.
Transportation Alternative Funds (TAP)	These are federal funds allocated on a competitive basis by the Commonwealth for projects related to pedestrian, bike, trails, historical and scenic improvements to the transportation network. Funding requires a local 20 percent match.
Congestion Mitigation and Air Quality Improvement Program (CMAQ)	This is a federal grant program for transportation projects with an aim to improve air quality passed through the State to the municipality via a statutory formula based on population and air quality classification as designated by the Environmental Protection Agency (EPA). These funds are budgeted for specific projects through the federally-mandated regional Metropolitan Planning Organization or MPO.
Highway Safety Improvement Program (HSIP)	This is a core federal-aid program with the purpose to achieve a significant reduction in traffic fatalities and serious injuries on all public roads, including non-State-owned roads and roads on tribal land. The HSIP requires a data-driven, strategic approach to improving highway safety on all public roads with a focus on performance.
State of Good Repair (SGR)	This program provides funding for deteriorated pavements and Poor Condition structurally deficient * (SD) bridges owned or maintained by the Virginia Department of Transportation (VDOT) and/or localities, as approved by the Commonwealth Transportation Board (CTB).
State Smart Scale	SMART SCALE is a statewide program that distributes funding based on a transparent and objective evaluation of projects that determines how effectively they help the state achieve its transportation goals.
Central Virginia Transportation Authority (CVTA)	The Central Virginia Transportation Authority is a newly-created authority in central Virginia that provides new funding opportunities for priority transportation investments across the region. The Authority will administer transportation funding generated through the imposition of an additional regional 0.7 percent sales and use tax (revenue collection begins October 2020) and a wholesale gas tax of 7.6 cents per gallon of gasoline and 7.7 cents per gallon of diesel fuel (revenue collection begins July 2020).
Revenue Sharing	The Revenue Sharing Program provides additional funding for use by a county, city, or town to construct, reconstruct, improve or maintain the highway systems within such county, city, or town and for eligible rural additions in certain counties of the Commonwealth. Locality funds are matched, dollar for dollar, that have state funds, with statutory limitations on the amount of state funds authorized per locality.
MPO RSTP	Regional Surface Transportation Program funds are provided to metropolitan planning organizations.
Pay-As-You-Go-Funds (Cash)	This is revenue allocated as a direct cash contribution.
Other Funding Sources - Prior Appropriations	These dollars represent debt appropriations formerly allocated to other Capital Projects that have either been (1) completed under budget or (2) discontinued.

The operating costs of a project, and any savings resulting from the project, are captured in the Operating Budget. The City carefully considers all potential operating impacts before including a project in the five-year plan. These considerations are also included in the City's five-year forecast.

# **CAPITAL PLANNING PROGRAM**

## **CAPITAL PLANNING PROGRAM OVERVIEW**

**Goals and Objectives:** The goal of the Capital Planning Program (the "Program") is to better align the City's Capital Improvement Plan (CIP) planning process with "Best Practices" of highly rated financial planning practices. The Program assists with:

- a. Long-term assessment of project need
- b. Better definition of project costs and scopes
- c. Long-term financial planning and management of debt affordability
- d. Greater accountability
- e. Minimization of project cost overruns

**Description and Scope:** Funding for advanced planning and design is used to design high priority projects for potential future funding. Advanced feasibility and planning work will help define project scopes, resulting in better cost estimates and allow for better decision making.

The feasibility of a project is continuously assessed as it moves through the planning process. If the project remains feasible after completing the planning phase, the project will enter the design phase. After planning and design phases have produced a cost estimate, which may take 12-18 months, the total project funding will be considered for inclusion in a future budget. This work creates a "project pipeline" and a pool of potential capital projects for future funding.

**History and Key Milestones:** The Program is new in the FY 2023 CIP budget with an initial funding amount of \$10.0 million. Projects selected for inclusion in the Planning and Design Program are based on the city's priority needs. Projects such as transportation and city facility projects that tend to be the larger, more complex projects, and can be included.

**Funding Sources**: Revolving Taxable G.O. Line of Credit authorized by Ordinance of the City. Spending on the Line of Credit will be permanently financed with GO Bonds. Provided that the initial spending is funded from draws on the Line of Credit, there are no timing or other limits if the City does not proceed with the project. This line of credit is revolving and will be reimbursed.

**Description & Scope:** The Public Art Program is funded by the Percent for Art Ordinance (97-3-41), adopted in 1997, mandating that qualifying new capital construction, improvements to public buildings, or pedestrian open spaces over \$250,000 shall contain a line item that equals 1 percent of the estimated project cost when the capital projects are submitted to Budget and Public Works staff. The adoption of the Public Art Master Plan (Ord. No. 2018-205) adds significant levels of public art throughout the city, especially in areas where access to art of any type is significantly lacking. The Percent for Art program ensures a dedicated stream of funding for Public Art, and strives to develop public art that reflects Richmond's history and culture by commissioning inspiring artwork in a diversity of styles and media by regional, national, and international artists.

**History & Key Milestones:** In 1991, the Planning Commission, on the recommendation of City Council, appointed a Public Art Commission (PAC) to administer a Public Art Program. In January 1997, Council passed an ordinance formalizing the Percent-forthe-Art process mandating its funding through the Capital Improvement budget. The Percent for Art Program is modeled after similar ordinances in 27 states and 350 cities nationwide. Since the inception of the Public Art Commission in 1991, 44 projects valued at \$1.43 million have been installed that need to be inventoried, assessed, and maintained on a regular basis. In 2018, the adopted Public Art Master Plan provided a vision for the future of public art in Richmond.

The City budgeted an additional \$875K in FY 2016 and received a matching \$875,000 from the Revenue Sharing funds for this project. This project is currently in right of way acquisition phase.

The shared use path to be provided will offer a multimodal space with buffer zone featuring streetscape and landscaping (e.g., trees or a grass strip) and street furniture (e.g., benches and trash cans) as appropriate. The project will greatly improve the Americans with Disabilities Act (ADA) accessibility of the corridor by providing continuous shared use path and standard ADA features associated with crosswalks and bus stops. This will ensure that non-motorized users of all ages and abilities can use the facility and safely navigate major roadway crossings.

**History & Key Milestones:** The Richmond Regional Transportation Planning Organization selected and submitted a Smart Scale application and it was selected for \$16.2 million. The proposed alignment in the application may not be the ideal or preferred alignment as it follows US Route 1. Alternatives may include Lynhaven Avenue or along existing railroad to better connect two new parks and to provide a better user experience than along a 6 lane arterial.

The proposed complete street will accommodate all users with adequate space for multimodal travelers, street trees, and sidewalk by repurposing existing roadway widths and reconfiguring intersection geometries. As a result, the overall function of Maury Street will be improved and the character of the Manchester neighborhood will be enhanced. This project is in line with the Richmond Regional TPO Commerce Corridor Study to support Richmond Marine Terminal.

In FY 2017, the Richmond Regional Metro Planning office allocated federal RSTP funds (100% reimbursable) to fund the rehabilitation project for the Mayo Bridge (FY 2017- \$500,000; FY 2018 - \$0; FY 2019 - \$0; FY 2020 - \$3 million; FY 2021 - \$1 million; FY 2022 - \$2 million). Additionally, VDOT State of Good Repair funds were sought and awarded to the project in the amount of \$1,750,000 (FY 2017 - \$625,000; FY 2018 - \$275,000; FY 2019 - \$0; FY 2020 - \$60,000; FY 2021 - \$790,000). The budget allocations have changed from the FY 2020 adopted to reflect changes in VDOT's adopted FY 2020 Six-Year Improvement Plan. The City has requested additional funds from the FY 2021 - 2022 Revenue Sharing Program to address the remaining need.

A construction expenditure of \$6.0M over five years is expected to bring a breakeven with O&M savings at between 20 and 30 years. This assumes a 50% power savings in each year of operation. DPU is currently engaged in a LED pilot assisted by experts from Virginia Tech Transportation Institute securing assistance with analysis of the selected LED lighting components under evaluation, cost-benefit impacts and to help establish LED standards for the City.

**History & Key Milestones:** The LED project has completed its pilot phase. The pilot phase was funded via prior O&M funds that were allocated for LED technology testing and evaluation. As of FY19-20, the LED Pilot program has transitioned to a system phased conversion from HPFS to LED lighting via the standards, technology and lighting level ranges developed during the pilot phase.

**Description & Scope:** This project supports infrastructure maintenance, such as roofs, boilers, and electrical upgrades. The Capital Improvement Plan, for FY 2023 through FY 2027, is used to identify, plan and fund the major building systems, infrastructure and site feature replacements to ensure a safe, reliable and sound instructional environment for the students, faculty and administration of Richmond Public Schools. The basis of this plan is determined by the life expectancy of major building systems (i.e. HVAC, Plumbing, etc.) as determined by the American Society of Heating, Refrigeration and Air-conditioning Engineers (ASHRAE) and recent surveys of problematic systems and/or components where recurring maintenance and/or repairs are no longer economically feasible.

**History & Key Milestones:** This project has provided numerous improvements to buildings and facilities throughout the school system, including, but not limited to: roof repairs and replacements, boilers, chillers, cooling tower repairs and replacements, HVAC repairs and replacements and electrical modifications to enable the buildings to support changing information technology infrastructure.

Richmond Public Schools has identified \$800 Million of capital funding needs over 20 years, which serves as the basis for the adopted Richmond Public School Capital Funding Plan. This capital project successfully provides \$800 million of school capital investment over 20 years, which would not exacerbate the estimated debt service related to the City's current level of CIP spending needs.

For each request to provide gas service, a determination is made whether the project provides a positive return to the gas utility.

- Projects may be completed where it is determined that subject to the Department of Public Utilities' Main Extension Policy, those projects will provide future profitable gas sales
- Where project costs are projected higher than net revenue, the customer can opt to pay a Contribution In Aid of Construction fee to make up that shortfall

**Description & Scope:** This project provides for the replacement of gas mains, services, meters, and regulators. The primary projects Included in this program are replacement of old gas mains, replacement or renewal of old gas services and response to water infiltration. Also, included are ancillary projects to renew or replace mains in conjunction with projects being done by other City agencies or the State. The Utility is estimated to replace approximately 120,000 feet of main and approximately 2,000 services in FY 2023. This project also allows for the purchase of replacement vehicles and equipment used to provide services throughout the Department of Public Utilities' Gas Utility service territory. Much of the gas distribution system is over 40 years old and is deteriorating due to its age. This project replaces and/or renews old gas facilities as maintenance costs begin to exceed replacement costs. This program reduces gas leakage and revenue loss.

**History & Key Milestones:** A federal USDOT mandate requires the City to replace all our cast iron gas mains and we are in the 21<sup>st</sup> year of a 40 year project to complete that task. New federal regulations requiring Distribution Integrity Management programs were effective on August 2, 2011.

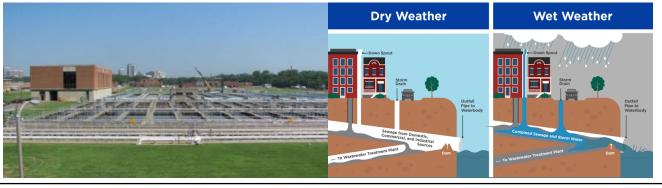

**Description & Scope:** As part of its VPDES Permit, CSO Special Order by Consent and the Regional Water Quality Management Plan (208 Plan), the City of Richmond is required to develop and implement a plan to control CSO discharges and meet Virginia water quality standards, as well as an ongoing CSO monitoring program and financial status review. This project implements the City of Richmond's Combined Sewer Overflow (CSO) Plan. The program includes design, engineering and construction of CSO conveyance facilities on the north and south sides of the James River, increases the wet weather treatment capacity at the Wastewater Treatment Plant, expansion of the Shockoe Retention Basin, and other smaller CSO control projects. In addition, this project included \$22.7 million for the Canal Redevelopment Project.

**History & Key Milestones:** The City completed Phase 1 of the CSO Control Program in the 1990s. Phase 2 was completed in 2003. The first set of Phase 3 CSO projects began in 2007 and will be continuing over the next 20 plus years.

**History & Key Milestones:** This project has been funded continuously over an extended period of time. Up until 2005, the annual sewer rehabilitation budget was about \$4.0 million per year, only covering emergency needs. Since then, this program has taken a more proactive role to rehabilitate sanitary sewers for an additional 50-100 years of life expectancy.

This project also allows for the purchase of replacement vehicles and equipment used to provide services throughout the Department of Public Utilities' Water Utility service territory. Rehabilitation and replacement of water mains are done on a systematic basis, with cost effectiveness and quality of water service in specific areas determining the projects to be completed. New water mains and services are installed as requested, with the customer paying for all work beyond a minimum amount per customer.

#### ACTIVE PROJECTS OVERVIEW

Active projects are classified as ongoing capital projects that have been funded in previous Capital Improvement Plans, but are not receiving any new funding in the current 5-year CIP plan. For example, if \$1,000,000 was awarded to a Community Center Renovation project in the FY 2022-2026 CIP, but it did not receive funding in the FY 2023-2027 CIP, then it would be considered an active project. In most instances, these projects have either received the full amount of funding necessary to complete the project, or are unable to be funded in the current plan due to limited debt capacity.

#### HIGHLIGHTED ACTIVE PROJECTS

There are currently 100 active projects listed in the FY 2023-2027 Capital Improvement Plan. Some of these projects include:

**Replacement of Fire Station 12** - Replacement of the current 110-year old Fire Station 12, located on 2223 West Cary Street with a new station (rendering below).



**New School Construction** - This project provides funding for the design and construction of new schools within the city, including Cardinal Elementary School, Henry L. Marsh Elementary School, and River City Middle School (pictured below).

#### AMERICAN RESCUE PLAN ACT (ARPA) OVERVIEW

On March 11, 2021, President Joe Biden signed into law the **American Rescue Plan Act of 2021** (commonly referred to as **ARPA**), a \$1.9 trillion economic stimulus package intended to support recovery efforts across the United States in the midst of the ongoing COVID-19 pandemic. The package includes a variety of different funding opportunities, including direct support for citizens, and payments to local and state governments, in order to facilitate widespread economic relief.to those most adversely affected by the pandemic and the ensuing recession.

The City of Richmond has been awarded a total of \$154 million through ARPA, to be distributed in the form of two \$77 million payments from the federal government one year apart from each other. On October 25, 2021, Richmond City Council adopted Ordinance 2021-291, which authorized the city to accept the first \$77 million payment, and then distribute funds as outlined in the city's proposed spending plan for the funding. The spending plan includes funding for priorities of both the Stoney Administration and City Council, Including contributions to initiatives that support affordable housing development, combat climate change, and provide equitable healthcare access, among other pivotal focus areas.

#### **ARPA CIP PROJECTS**

Investment in capital projects is another focal point of the city's ARPA spending plan, as a total of \$28.3 million was appropriated to the FY 2022-2026 Capital Improvement Plan for the creation and implementation of 8 new capital projects. These 8 projects include phased neighborhood redevelopment, new community centers, trails, and green space, and funding the creation of a master plan for the city's park system. These bold investments in the city's future provide recreational space for both children and families, resulting in access to a higher quality of life for all Richmonders.

# HIGHLIGHTED ARPA CIP PROJECT - SOUTHSIDE REGIONAL PARK AND COMMUNITY CENTER

This project funds the construction and renovation of a Southside Regional Park and Community Center, located at 6255 Old Warwick Road. The expanded community center will provide needed activity space, including after-school programs, tutorial assistance, teen programs, summer playground and camps, summer USDA food programs, and arts, crafts, and cultural programs. The center would also provide needed space for senior programs and community and family events (rendering below). Note that, while this project was established prior to ARPA, the funding allocated through the ARPA plan is expected to complete construction work on the project.
