2023 HEALTH ASSESSMENT INITIATIVE

For employees, eligible retirees, and spouses enrolled in a Cigna medical plan



All City of Richmond employees, eligible retirees, and spouses enrolled in a Cigna medical plan are eligible to participate in the 2023 Health Assessment Initiative for a reduced healthcare premium rate in 2024.

To receive the healthcare **premium incentive**, you and your spouse if covered under your plan MUST complete the online Health Assessment by August 31, 2023. City of Richmond will NOT be hosting biometric screenings this year, but you will be asked to enter your biometric information.

If you have received an annual physical in the past year, you can update your health assessment with those biometric numbers (HEIGHT, WEIGHT, WAIST CIRCUMFERENCE, BLOOD PRESSURE, TOTAL CHOLESTEROL, and HDL CHOLESTEROL).

If you haven't received an annual physical in the last year, we encourage you to make an appointment with your Primary Care Physician OR set up a wellness visit through MDLIVE.

To take the online health assessment:

*Log on to www.myCigna.com, > Wellness > Health Assessment and complete between July 1 - August 31, 2023.

To set up a wellness visit with MDLIVE go to **myCigna.com**, locate the "Talk to a doctor" then locate Medical click on "Continue" then find Primary care to click on "Schedule a Visit".

1. Complete your MDLIVE health questionnaire.

- 2. Choose an in-network lab such as Lab Corp or Quest and schedule an appointment.
- 3. Choose an MDLIVE provider and schedule your virtual visit.
- 4. Go to your lab appointment. You'll receive a notification when the results are available in the MDLIVE customer portal.
- 5. Attend your virtual visit from anywhere via video or phone. After your visit, you'll receive a summary of your screening results for your records.

Reminder: To receive a reduced healthcare **premium rate** in 2024, you and your spouse if covered on your medical plan, MUST complete the online health risk assessment between July 1 - August 31, 2023.
