The Civilian Review Board shall consist of 8 members. Four members are appointed by the Council and four are appointed by the Mayor. Members will serve three-year terms and will play a vital role in reviewing, investigating, and making recommendations to City Council, the Mayor, and the Chief of Police on specific internal investigations to ensure accuracy, completeness, and impartiality.

Board members can expect to attend one to two monthly meetings, participate in seven weeks of training, attend community events, and have a dedication to justice, fairness, and community engagement.
