Instructions to voters

To vote for a candidate, use a black pen to fill in the oval next to the name, like this:



To vote on an issue, fill in the oval next to Yes or No.

To write in a person who is not already on the ballot, fill in the oval and write the name of the person on the line.



If you want to change a vote or if you have made a mistake, ask an election worker for another ballot. If you make marks on the ballot besides filling in the oval, your votes may not be counted.

Instrucciones para votantes

Para votar por un candidato, utilice un bolígrafo negro para llenar el óvalo junto al nombre, como así:



Para votar sobre un tema, llenar el óvalo junto al "Sí" o "No".

Para escribir a una persona que no está en la boleta, llenar el óvalo y escribir el nombre de la persona en la línea "Por escrito".
