VALID January 1, 2025 to December 31, 2025

RESTRICTED PARKING DISTRICTS - DEFINITIONS AND REQUIREMENTS

- You must be a resident of the Carver District to obtain a Carver Parking Decal/Permit, Annual Visitor Pass or Courtesy Parking
 Permit. A resident is defined as a record owner or renter of property in the district and members of their immediate family who reside
 with the owner or renter at the address in the Carver.
- A property owner may obtain up to 2 annual visitor passes for the property address at the same time the Carver permit is obtained.
- If DMV requires that the vehicle be registered as garaged in the City of Richmond, all City taxes and fees must be paid prior to obtaining a Carver permit. Students must be full-time to meet the residency requirements and comply with the vehicle registration requirements of the Virginia Department of Motor Vehicles (DMV).
