

The 2<sup>nd</sup> Street Summit took place on June 29, 2024. The goal of the 2<sup>nd</sup> Street Summit was to bring residents, businesses, property owners, and community leaders together to discuss the future vision for 2nd Street and identify specific strategies that the community could implement to propel 2nd Street further towards that vision. The 2<sup>nd</sup> Street Summit included three major sessions: a walking tour of 2<sup>nd</sup> Street, visioning and strategy-making activities, and a dynamic drawing activity. In total, 34 participants attended the 2<sup>nd</sup> Street Summit.

### Promotion

The 2<sup>nd</sup> Street Summit was promoted by means of a postcard mailing, flyers, email, civic association meetings, and city website.

- Postcards were mailed to all property owners who owned parcels within the area bounded by 1<sup>st</sup> Street to the west, Duval Street to the north, 3<sup>rd</sup> Street to the east, and Broad Street to the south. Property owners were invited to attend and were encouraged to send a representative on their behalf if they could not attend.
- Flyers advertising the event were also created. Community ambassadors walked door to door distributing these flyers to businesses along 2<sup>nd</sup> Street.
- The Historic Jackson Ward Association helped spread the word to their members at their regular civic association meeting.
- Information about the event was also included in the Richmond 300 newsletter and was sent out to those signed up on the Richmond 300 mailing list.
- Information about the event was also posted on the PDR-Jackson Ward webpage of the city website.

#### **Public Meeting Summary**

PDR staff held the 2<sup>nd</sup> Street Summit on June 29, 2024. The walking tour began at Maggie L. Walker Statue and Memorial Plaza. After the tour, attendees convened at The Speakeasy at the Hippodrome, an event venue located on 2<sup>nd</sup> Street, to engage in further activities and discussion. In total, 34 participants attended the Summit. Participants included longtime Jackson Ward residents, business owners, property owners, and organizational/civic leaders.




Top Strategies to Improve 2<sup>nd</sup> Street:

- Trees/landscaping along 2<sup>nd</sup> St from Marshall to Maggie Walker Place, and also along 200 blk of Leigh Street
- Benches (historical murals) along 2<sup>nd</sup> St, Clay, Leigh and Jackson Sts
- Lights in alleyways between 1<sup>st</sup> and 2<sup>nd</sup> Streets
- Parking lot near Buna Kurs/Sugar & Salt reimagined as green space, as well as a vacant lot behind Maggie Walker NHS reimagined as green space
- 2<sup>nd</sup> Street closed to vehicular traffic from Friday evening to Sunday
- Vacant parcels at the northeast corner of 2<sup>nd</sup> and Jackson Sts reimagined as a hotel
- Houses along Maggie L. Walker Place cul-de-sac
- Parking options nearby on the other side of 3<sup>rd</sup> Street

Top Strategies to Improve 2<sup>nd</sup> Street:


- Tourism Station

Standout Drawn Elements on Map:

- Grocery store/ pharmacy close to Broad Street
- Streetscape improvements (trees/shrubs/lights/ new street signs specific to 2<sup>nd</sup> St/ brick sidewalks) all along 2<sup>nd</sup> Street from Broad to Jackson Sts
- New street signs that are made of iron rods (New Orleans style) (historic charm) at all intersections from Broad to Jackson Sts
- Cleaning crew dedicated to 2<sup>nd</sup> Street



- Traffic calming (including improved pedestrian crosswalks) at all intersections along 2<sup>nd</sup> St, 1<sup>st</sup> St, and 3<sup>rd</sup> St intersecting with Marshall, Clay and Leigh.
- Marshall and 1<sup>st</sup> Parking lot reimagined as Frequent festivals, farmers market, outdoor dining, and food trucks




Top Strategies to Improve 2<sup>nd</sup> Street:

- Create 2<sup>nd</sup> Street-specific development group, to include representation from Venture Richmond, corporate stakeholder/anchor, U of R/VUU/VCU, Historic Jackson Ward, RRHA board member, City of Richmond, with subcommittee of bigger developers (no voting power).
- 2. Create program of economic incentives and consequences, like building permit waiving, business fee waiving, expediting, and façade grants.
- 3. Plant/ repair tree wells. Bury power lines.
- 4. Create a Jackson Ward visitors center.
- 5. Decrease car traffic/ car presence.
- 6. Encourage/increase nightlife, longer store hours, and more creative lighting.
- 7. Develop more programming i.e. First Friday.
- 8. Focus on families and children.

Standout Drawn Elements on Map:

- Visitor's Center at Broad Street, close to buses/transit
- Kids Zone close to Broad Street
- Street trees along entire stretch of 2<sup>nd</sup> St, and also along Clay and Leigh Sts
- Bulb-outs at some corners
- SPARC visual arts center for kids near Leigh and 1<sup>st</sup> Sts
- Parking lots reimagined as retail storefronts facing 2<sup>nd</sup> St, with apts behind and parking beneath
- Vacant parcels at the northeast corner of 2<sup>nd</sup> and Jackson Sts reimagined as a hotel
- Apartments at the Maggie L Walker Place cul-de-sac, with townhomes facing 2<sup>nd</sup> Street
- Signs 2 at Duval Street
