OAA OPERATION STOP! RECOVERY HOUSING

The City of Richmond's Office of Opioid and Substance Use Response announces the availability of funds through the Virginia Opioid Abatement Authority's Operation STOP! (Specifically Targeted Overdose Prevention) initiative.

Operation STOP! is a grant program that directs funding to Virginia cities and counties with the highest increases in fatal overdoses disproportionately affecting Black residents. The City of Richmond was awarded \$150,000.00 by the Virginia Opioid Abatement Authority that will be subgranted to charitable organizations through this solicitation in support of eligible activities during Fiscal Years 2026-2028.

This subgrant award is available for eligible organizations to implement or expand recovery housing access to City of Richmond residents through the provision of, "bed fee scholarships." Proposals should describe how activities will engage communities disproportionately affected by opioid-related harms and demonstrate cultural competence in serving those populations.

The selected organization(s) shall work directly with individuals in this priority population who seek recovery housing.

Eligible applicants must be charitable organizations registered with the Virginia State Corporation Commission who may be:

- Certified recovery residences proposing to provide bed nights at no cost to members of this target population
- Registered non-profit organizations including (but not limited to) Federally Qualified Health Centers (FHQC) and outreach organizations working within this population proposing to manage a fund that would be used to pay for "bed fees" at certified recovery residences

Collaborative proposals involving more than one recovery residence or other registered non-profit are welcomed and encouraged.

The City expects funded programs to demonstrate meaningful impact through increased accessibility and availability of recovery housing to communities disproportionately affected by opioid-related harms including increased rates of overdose fatalities. Eligible organizations must comply with [Virginia Opioid Abatement Authority Grant Award Terms and Conditions for Individual Distributions to Cities and Counties](#).

Submission and Award Notice:

- Applications, including all required attachments, must be submitted by email to opioidresponse@rva.gov no later than **Friday October 31st, 2025 by 5:00 PM**. Late applications will not be accepted.
- The City expects to notify successful applicants by email no later than **5:00 PM on Friday, November 21st, 2025**.

Funding Amount

- A total of \$150,000 is available through this RFA.
- Applicants may submit proposals requesting up to \$150,000.00.
- The City anticipates funding no more than three proposals that collectively will not exceed the total available funding amount.

ELIGIBILITY THRESHOLD

- Applicants must be charitable organizations authorized to conduct business in the Commonwealth of Virginia and be in good standing with the City of Richmond.
- Applicants that are Recovery Residences must have accreditation through the Virginia Association of Recovery Residences.
- Applicants must be in compliance with all federal, state, and local regulations, and have no outstanding violations, taxes, or penalties.
- Applicants must disclose any lawsuits to which they have been a party in the past three years, as well as any lawsuits and investigations, criminal or otherwise, relating to the financial or business practices of the organization that are pending at the time of application.
- Applicants must provide all application elements and attachments listed below:
 - Proof of liability insurance
 - Federal tax-exempt certification
 - Most recent IRS Form 990 (Must be a complete 990. Form 990-N will not be accepted)
 - Project budget
 - Current year operating budget

Application Elements:

1. **Cover Sheet:** See Attachment A
2. **Narrative:** The completed narrative must have the following components and should be no longer than 5 total pages:
 - a. **Organizational Background and Capacity:** Briefly describe the organization's mission, history, and relevant experience in implementing an initiative of this kind. How has your program demonstrated success in the past (what quantitative and qualitative data can you share, how many people have you helped or supported, results of your program, etc.)?
 - b. **Program Description:** Provide a detailed description of the proposed project and the services that will be provided as a result of this funding. Please indicate your process for identifying individuals in need of, "bed fee scholarships," and how you will connect them to services or directly provide services. Share the ways in which your program utilizes

evidence-based or evidence-informed practices to support individuals with Opioid Use Disorder.

- c. **Cost-Effectiveness and Sustainability:** This is a one-time funding opportunity. Please articulate how these funds will be leveraged to drive impact in FY 2026-2028, and how your organization will adapt in future years in case of reduced funding availability. Can this project be delivered if you only receive partial funding? If so, how?
 - d. **Data and Reporting:** How will you track your effectiveness (e.g. data (qualitative and quantitative), performance measures, participant feedback)? Please provide a description of the data you plan to collect and your approach to reporting.
3. **Budget:**
 - Using the provided template, or your own template with at least the same level of information, please provide a complete project budget.
 4. **Budget Narrative:**
 - In a concise manner, please explain the costs in each budget category, including which budget items will be covered by the grant and which ones will be covered by other sources of funds. Please include a short justification of each proposed line item describing the programmatic relevance.
 5. **Timeline:**
 - In a format of your choosing, please provide a project timeline with key milestones.

Review Criteria - Applications will be evaluated based on the following criteria:

Community Impact and Outcomes (30 points)

- Demonstrated experience and success working with communities disproportionately impacted by opioid-related harms and demonstrated cultural competence in serving those populations
- Potential for meaningful impact on target population
- Alignment with community needs and priorities

Program Design (25 points)

- Clarity and feasibility of program model
- Integration of evidence-based and evidence-informed practices in service provision

Organizational Experience and Past Performance (20 points)

- Organizational stability and track record of past performance. In partnership with the City of Richmond and/or in other settings, the applicant has demonstrated the capacity to complete the proposed project.
- Staffing qualifications and expertise

Cost-Effectiveness and Budget (15 points)

- Clear, reasonable, and well-justified budget
- Cost per participant/outcome
- Leveraging of additional resources
- Sustainability planning

Data Collection and Evaluation (10 points)

- Clear data collection plan and reporting capabilities
- Appropriate performance measures

Review Process Steps

- **Eligibility Screening:** All applications will be screened for completeness and eligibility requirements
- **Technical Review and Scoring:** Eligible applications will be evaluated against the review criteria by the scoring committee of subject matter experts.
- **Final Selection:** The scoring committee and City leadership will together review the top scoring applications to identify 1-3 grantees for funding. A minimum score of 80 will be required to advance to the final selection phase.
