Canvass/ Provisional Ballot Review  
January 7<sup>th</sup> and January 9<sup>th</sup>, 2026

### **RECONVENED MEETING**

#### **Call to Order**

The meeting was reconvened at **2:41 p.m.**

### **CHANGE IN SECRETARY**

Chair **Bill Pantele** made a motion that Vice Chair Joyce K. Smith serve as **Acting Secretary** due to unforeseen health circumstances of **Secretary Cherlyn S. Stevens**.

**Vote:** All in favor.

**Motion passed.**

### **PROVISIONAL BALLOT REVIEW**

- **Precinct 909 (Hickory Hill Early Voting):**

- 1 SDR submitted
  - **Motion to approve**
  - **Approved unanimously**

- **Precinct 402:**

- 3 ballots reviewed
  - **Recommendation: Approve 1 SDR**
  - **2 ballots** were voters who requested absentee ballots but did not bring or surrender the ballot; one ballot had been returned to the office

## **11. Open Session – Final Provisional Determinations**

Chair Bill Pantele motioned to accept the following provisional ballots:

- **Precinct 412:**
  - 5 ballots entered
  - 1 SDR
  - Absentee ballot issued but not returned
  - **2 ballots accepted**
- **Precinct 812:**
  - 1 ballot entered
  - 1 SDR
  - **Recommended and counted**
- **Last Provisional Ballot (In-Person / AB Conflict):**
  - Absentee ballot was mailed
  - Voter voted in person
  - **Ballot rejected**
- **Precinct 814:**
  - 2 provisional ballots
  - 2 SDRs
  - Research showed voters belonged to **Precinct 811**, which was not part of this election
  - **Both ballots rejected**
- **Precinct 903:**
  - 1 voter issued absentee ballot
  - Ballot was not returned
  - **Ballot recommended to be counted**
- **Precinct 910:**
  - 1 provisional ballot
  - **Accepted**
- **Precinct 911:**
  - 3 provisional ballots
  - 1 voter already registered at address
  - 1 absentee ballot not surrendered but returned unmarked (blank Envelope B)
  - **All 3 ballots accepted**

## **12. Final Totals**

- **Total provisional ballots reviewed: 20**

- **Accepted: 17**

- **Rejected: 3**




